GRANTS - THE IMPACT FUND MAKES RECOVERABLE GRANTS TO LAWYERS, SMALL LAW FIRMS, AND NONPROFIT ORGANIZATIONS INVOLVED IN IMPACT LITIGATION. WE FUND CIVIL RIGHTS, HUMAN RIGHTS, ANTI-POVERTY, AND ENVIRONMENTAL JUSTICE CASES THAT WILL AFFECT A MARGINALIZED GROUP. MOST OF OUR GRANTS ARE FOR CLASS ACTIONS, BUT WE ALSO FUND MULTI-PLAINTIFF AND ENVIRONMENTAL JUSTICE CASES THAT AIM TO SIGNIFICANTLY AFFECT A LARGER SYSTEM OR LEAD TO SIGNIFICANT LAW REFORM. IN THE 2021/22 FISCAL YEAR, THE IMPACT FUND DISBURSED A TOTAL OF \$385,635 IN GRANT FUNDING VIA 24 RECOVERABLE GRANTS. THE IMPACT FUND HAS COMMITTED AROUND \$8 MILLION TO JUSTICE-RELATED CAUSES SINCE THE ORGANIZATION'S INCEPTION.

ADVOCACY - WE ADVOCATE FOR ECONOMIC, ENVIRONMENTAL, RACIAL, AND SOCIAL JUSTICE AS BOTH LEAD AND CO-COUNSEL IN A SMALL NUMBER OF COMPLEX IMPACT LITIGATION CASES. WE ALSO AUTHOR SEVERAL AMICUS BRIEFS IN IMPORTANT CLASS ACTION CASES EACH YEAR AND PARTICIPATE IN NOTICE AND COMMENT RULEMAKING FOR ADMINISTRATIVE RULES AND REGULATIONS ON RELEVANT ISSUES.
