As part of its public interest litigation the Organization litigated the class action *Ellis v. Costco* which was filed in 2004. This case challenged Costco's practices with respect to the promotion of women into management. Our clients claimed that Costco operated a "glass ceiling" that stopped women from being promoted to assistant manager and general manager positions in the popular retail warehouses.

The court-approved settlement agreement established a claims process through which class members may make claims that they were denied promotions because of their gender. Costco also agreed to work with an independent consultant to analyze its promotion policies and practices, and has committed to making several significant changes to its promotion processes for managers.

The Organization received fees for its work of approximately \$1,565,928 during the year ended June 30, 2019. Some of this amount reflects work performed during the 15 years of litigation with respect to the case and to certain post settlement activities.
