

TERMS OF USE

IMPORTANT – THIS IS A LEGAL AGREEMENT BETWEEN YOU AND THE IMPACT FUND, INC. (“IMPACT FUND” OR “WE” OR “US” OR “OUR”). THE WEBSITE LOCATED AT WWW.IMPACTFUND.ORG, IS OWNED AND OPERATED BY IMPACT FUND. BEFORE ACCESSING OR USING ANY PART OF THE WEBSITE, YOU SHOULD READ CAREFULLY THE FOLLOWING TERMS AND CONDITIONS CONTAINED IN THIS TERMS OF USE AGREEMENT. 1. Description of Impact Fund and The Website

Impact Fund provides strategic leadership and support for litigation to achieve economic, environmental, racial, and social justice. We provide funds for impact litigation in the areas of civil rights, environmental justice, and poverty law. We offer innovative technical support, training, and expertise on issues that arise in large scale impact litigation. We serve as lead counsel, co-counsel, and amicus counsel in select class action and impact litigation.
